KEY UPDATES

- Watch for construction at the three way stop in Barry's Bay - lane widening at the intersection of Highways 60 and 62 (Opeongo Line and Bay Street) will take place from August 25 to September 12. The intersection will be closed from September 8 to September 12.

- The Township is currently undertaking a review of its Comprehensive Zoning By-Law 2006-26. Planning consultants are working to present a draft at public meetings to be scheduled in early fall. Stay tuned for updates on our website, social media platforms, and municipal corner newspaper page.
- The Township is excited to announce we are the recipients of an Ontario Trillium Capital Grant for 2025-26! This grant will see the rehabilitation of the Combermere Community Centre's outdoor rink, including a new ice pad, boards, and multisport lines on the surface. Construction will begin in 2026.
- Looking to get a shipping container on your property? By-Law 2024-44 addresses the use of shipping or sea containers as storage units. Minimum property sizes and depth/width apply in all zones, and in residential zones a maximum of one storage container is permitted. Commercial, rural, or industrial zones may have more than one dependent on lot size. Storage containers are buildings and require building permits under the Ontario Building Code.

TAX BILL CHANGES: OPP SERVICE BILLING UPDATES

During a Regular Meeting of Council in the spring of 2025, the decision was made to remove the Ontario Provincial Police Services Billing from the General Tax Budget and apply the cost of the police services equally to every property in the Township of Madawaska Valley as its own separate Levy.

The OPP Services Billing is calculated by the Province of Ontario based on household counts, population counts and call for service, and the Council and Staff have no control of the expenses related to policing. Therefore, it was decided that the fees for this service should be applied to the property tax bill as its own levy. The 2025 cost of \$916,105.00 for police services will be shared amongst every property at a rate of \$211.91. This levy will fluctuate year over year based on annual billings received by the province and as property counts increase and/or decrease.

The annual tax rate has been adjusted to reflect the removal of the \$916,105 police services. You will see this shared levy appear on your Final Tax Bill as "OPP".

DID YOU KNOW? Of the taxes billed to Township of Madawaska Valley residents, 49.9% stays within the Municipality, 36.5% is sent to the County of Renfrew, and 13.6% is sent to school boards.



BLUE BOX TRANSITION UPDATE

Blue Box recycling changes are coming to ratepayers in the municipality as of January 1, 2026, as the Province has mandated producers of recyclable materials to be responsible for managing the packaging they produce with their products. The Township is working closely with Circular Materials Ontario to determine how best to serve ratepayers with the new program changes. As more information is available, it will be shared to ensure residents and businesses remain informed about what the new program will look like and how to participate. NUISANCE BEAVERS

When beaver dams on private property break, they can result in significant damage property, including yours and neighbouring properties. It is your responsibility to ensure beavers on your property are managed properly and their activities will not result in damage to neighbouring private and public land.

Beavers can be humanely killed or trapped by an agent should they be damaging or at risk of damaging property. The Township keeps a list of licensed trappers - reach out to dclerk@madawaskavalley.ca to access the list, or add your name if you are a licensed and insured trapper. The Township is responsible for managing nuisance beavers impacting Township property, including roadways. To report a nuisance beaver impacting a roadway, contact the Operations Department.
