### NOTICE OF APPLICATION AND PUBLIC MEETING

**In the matter of Section 45 of the Planning Act, the Township of Madawaska Valley hereby gives Notice of an Application for Minor Variance**

**Subject Lands:** 272 Ohio Road, being part of Lot 5, Concession 6, in the geographic Township of Radcliffe, Township of Madawaska Valley.

**Purpose and Effect:** The purpose and effect of the Minor Variance application is to request relief from Section 3.30 d) of the Zoning By-law to permit the reconstruction and enlargement of an existing dwelling within the required 30 metre water setback. The dwelling seeking to be reconstructed as part of this application is located adjacent to Madawaska River on the east side of the subject property, as identified on a separate map attached to this notice.

**PLEASE TAKE NOTICE** that the Township of Madawaska Valley Committee of Adjustment will hold a public hearing in accordance with Section 45 of the Planning Act on **June 2<sup>nd</sup>, 2026 at 9:45 a.m.**
